4. BUSINESS.

4.1. Façade Updates: 117 Meridian St N – Kristine Koniarski

Community Development Director Smith Strack explained Kristine Koniarski of Johan's Bar and Grill has applied for a Small Cities Development grant for commercial rehabilitation at her property at 117 Meridian Street North. Smith Strack explained the façade updates proposed as part of the grant project include enlargement of existing storefront windows, painting of front façade, awning, and removal/replacement of existing stone. Smith Strack noted Eric Oleson of Oleson Hobbie Architects has created a façade sketch illustrating the proposed façade changes. Smith Strack explained the committee is to review and comment on the proposed façade changes.

Eric Oleson of Oleson Hobbie Architects explained he met with the owner, reviewed the needs and proposed the sketch dispersed. Oleson explained the signage is nonlight and goose neck lighting is proposed.

4.2. Façade Updates: 149 Meridian St N - Ken Meger

Community Development Director Smith Strack explained Ken Meger has applied for a Small Cities Development grant for commercial rehabilitation. Smith Strack explained Meger proposes replacement of second story windows, treatment of existing sign band and painting of façade.

Eric Oleson of Oleson Hobbie Architects has created façade sketches illustrating the proposed façade changes. Oleson reviewed the proposed updates and explained the paneling would be pre-engineered material with a 50 year warranty. Oleson noted the material has been used on other projects, is durable and recommended due to finish.

Commissioner L. Lawler inquired when the committee would find out the color of the windows, banner and bottom. Oleson explained he has suggested a darker bronze and noted the owner is also looking at tuck-pointing the storefront.
